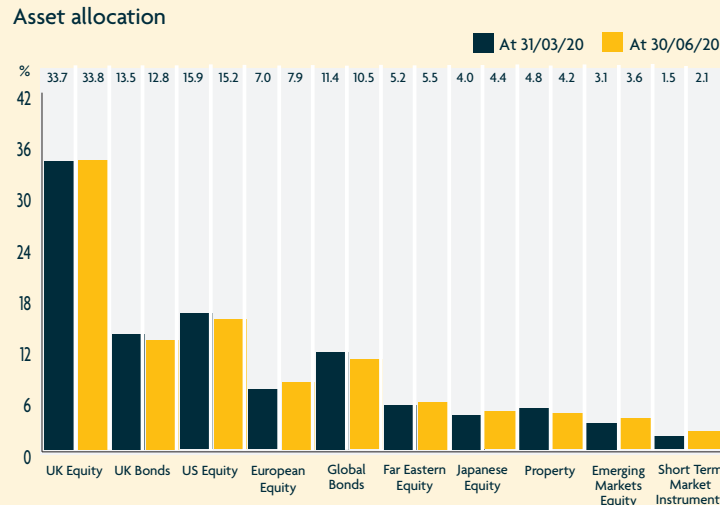

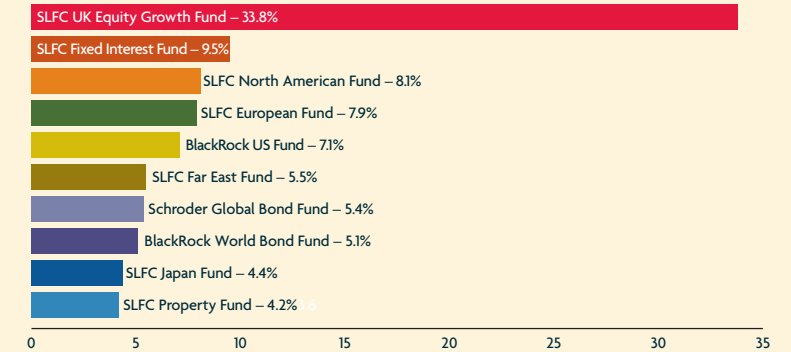

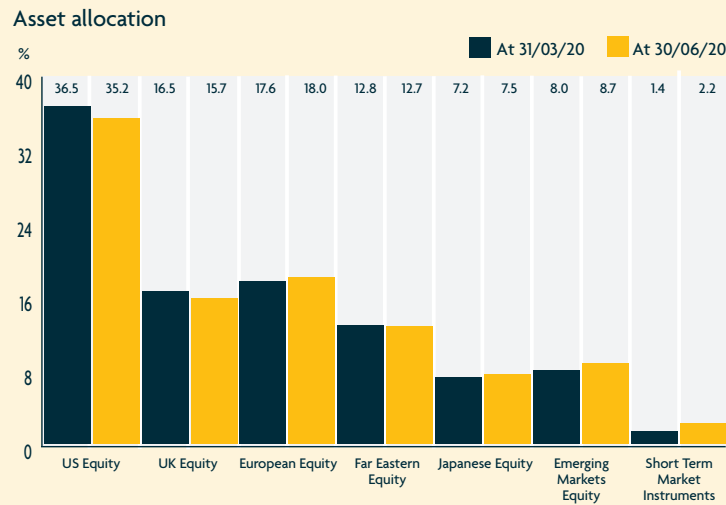


Top 10 holdings as a percentage of the value of SLFC Balanced Managed fund

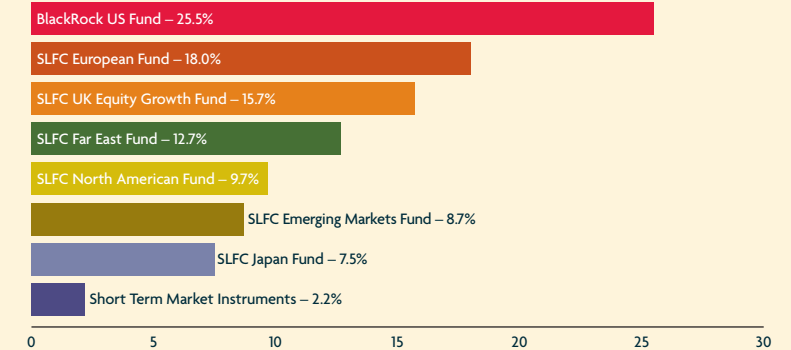
